

THE CORPORATION OF THE TOWNSHIP OF GREATER MADAWASKA

BY-LAW NUMBER 10-2016

Being a By-Law to authorize the Mayor and Clerk to execute an agreement with the Town of Renfrew respecting the provision of recreation services for the period from April 1, 2016 to March 31, 2017

WHEREAS Section 11 of the Municipal Act, 2001, empowers the Corporation of the Township of Greater Madawaska to pass by-laws and to enter into agreements respecting matters within the culture, parks, recreation and heritage sphere of jurisdiction;

AND WHEREAS Section 391 of the Municipal Act, 2001, enables a municipality to pass by-laws imposing fees or charges on any class of persons;

AND WHEREAS The Council of the Corporation of the Town of Renfrew is the owner of various recreational facilities and parks located within the Town;


AND WHEREAS the Township of Greater Madawaska is desirous to enter into an agreement with the Town of Renfrew respecting the use of and access to recreation programs and facilities offered by the Town of Renfrew.

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF GREATER MADAWASKA ENACTS AS FOLLOWS:

1. **THAT** the Agreement attached hereto as Schedule "A" and made part of this By-Law shall constitute a contract between the Corporation of the Town of Renfrew and the Corporation of the Township of Greater Madawaska.
2. **THAT** the Mayor and Clerk are hereby empowered to do and execute all things, papers and documents necessary to the execution of this by-law.
3. **THAT** this By-Law shall come into force and take effect immediately upon the passage thereof.

READ a first and second time this 22nd day of March, 2016.



**SCHEDULE A
BY-LAW 10-2015**

AGREEMENT

Made this 22nd day of March, 2016

BETWEEN

The Corporation of the Township of Greater Madawaska

AND

The Corporation of the Town of Renfrew

WHEREAS the Town of Renfrew and the Township of Greater Madawaska wish to enter into a shared services agreement for the provision of recreational programs and services;

AND WHEREAS the Township of Greater Madawaska wishes its residents to have access to the programs and facilities of the Town of Renfrew;

AND WHEREAS the Town of Renfrew is prepared to grant such permission to the residents of the Township of Greater Madawaska;

THEREFORE the parties hereto agree as follows:

1. The Town of Renfrew will provide human resources support and assistance to the Township of Greater Madawaska in the planning, organizing and implementation of recreation programs and services;
2. Residents of the Township of Greater Madawaska shall be permitted to participate in activities and programs and to use all the facilities operated by the Town of Renfrew Parks and Recreation Department in the same manner and on the same conditions as residents of the Town of Renfrew.
3. The Recreation Coordinator shall provide monthly updates to the Community Affairs Officer who will in turn provide quarterly update to the Council of the Township of Greater Madawaska.
4. The Recreation Coordinator reports to the Community Affairs Officer at the Township of Greater Madawaska
5. The Recreation Coordinator will develop a Work Plan and provide to the Community Affairs Officer by March 31, 2016. Furthermore the Recreation Coordinator will provide weekly reports on time spent on the Township of Greater Madawaska and submit their weekly calendar to the Community Affairs Officer.
6. The Township of Greater Madawaska will develop goals for the Recreation Coordinator along with the Town of Renfrew's Director of Recreation.
7. The Recreation Coordinator will be in the Greater Madawaska every Thursday, unless alternate arrangements have been made.
8. It is agreed that the Township of Greater Madawaska will pay the Town of Renfrew the annual fee of \$21,500 plus associated staffing costs (Mileage, Training, Cellular Phone) for the clauses above. Plus applicable taxes:

The Town of Renfrew shall submit an invoice to the Township of Greater Madawaska in June, with payment due upon receipt.

9. This agreement shall be for a period of one (1) year commencing April 1, 2016 with the option to extend should both parties agree.

10. Either party may terminate this agreement at the end of the agreement upon the giving of sixty (60) days notice in writing to the other party at its Municipal Office.

11. This agreement may be amended by the parties to the agreement, by mutual agreement at any time after commencement.
