- i) Application to amend the Zoning By-law 22-2003 of the Township of Greater Madawaska.
- ii) A public meeting regarding an application for an amendment to the Zoning By-law 22-2003 of the Township of Greater Madawaska.

## **Subject Lands**

150B Adam Ben Lane, Located in Part of Lot 13 & 14, Concession 1, geographic Township of Blythfield, as shown on the attached Key Map.

## **Public Meeting**

A public meeting to inform the public of the proposed zoning amendment will be held on **Thursday, October 12**<sup>th</sup>, **2023 at 3:00 p.m.** at the municipal office of the Township of Greater Madawaska.

## **Zoning By-law Amendment – Purpose and Effect**

The purpose of the proposed zoning by-law amendment is to pass a temporary use by-law to permit a Garden Suite as a temporary use on the subject lands. The Planning Act defines a Garden Suite as a one-unit detached residential structure containing bathroom and kitchen facilities that is ancillary to an existing residential structure and that is designed to be portable. Additionally, the proposed Garden Suite will have a reduced water setback from 30.0 metres to 7.8 metres from the high-water mark of Calabogie Lake.

The temporary use by-law would have a duration of three (3) years from the date of passing of the by-law. Upon the expiration of the 3-year period, Council may by by-law grant further periods of not more than three years each during which the temporary use may continue to be authorized and must be supported by a Geotechnical report. At such a time when the garden suite is no longer required or the temporary use by-law expires and is not extended, the garden suite is then to be removed from the subject lands.


The effect of the amendment is to rezone the subject lands to Limited-Service Residential Exception Sixty-One-Temporary (LSR-E61-t).

Additional information regarding the Zoning By-law amendment is available for inspection at the Township of Greater Madawaska Municipal Office during regular office hours.

If a person or public body would otherwise have an ability to appeal the decision of Township of Greater Madawaska to the Ontario Land Tribunal (OLT) but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Greater Madawaska before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Greater Madawaska before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If you wish to be notified of the decision of Township of Greater Madawaska on the proposed zoning by-law amendment, you must make a written request to Township of Greater Madawaska at the address below.



Note: One of the purposes of the Planning Act is to provide for planning processes that are open, accessible, timely and efficient. Accordingly, all written submissions, documents, correspondence, emails, or other communications (including your name and address) form part of the public record and will be disclosed/made available by the Municipality to such persons as the Municipality sees fit, including anyone requesting such information. Accordingly, in providing such information, you shall be deemed to have consented to its use and disclosure as part of the planning process.
